Pre-qualification process

	Review relevant certifications for your contractors to work on your property. Ensure you have an effective tool for this task, like a farm management app.		
	Review the contractor's references to understand their past work and potential fit within your business.		
	Ensure that contractors have the necessary insurance to work on your property.		
Documentation			
	Ensure all contracts are signed, legally compliant and properly stored		
	Ensure you have multiple ways to contact your contractors, including phone numbers, email addresses or a farm management app.		
	Create and maintain records of additional documentation like timelines, job descriptions, and your contractor management policy.		



Risk assessment

Analyse risks associated with contractors working in lone working contexts.
Determine risks that machinery may pose to contractors.
Identify hazards that may be caused by herbicides, pesticides and other hazardous chemics.
Explore whether contractors will need to work at heights during their time on your farm, and risks that can be associated with these activities.
Create a corrective actions record, identifying the solutions you will use to reduce these risks to the lowest possible levels.



Compliance

	Familiarise yourself with health and safety regulations in your jurisdiction and analyse how they will affect your contractors.		
	Ensure that your contractor arrangements are totally compliant with labour laws.		
	Make sure that your contractors are familiar with your farm's environmental regulations.		
Monitoring and supervision			
Ш	Establish digital or analogue systems for monitoring employees.		



Induction

Ensure that contractors have a complete understanding of policies on your farm, from antiharassment to biosecurity.
Provide a tour of your property to your contractors.
Walk contractors through emergency protocols on your farm.
Provide an in-depth overview of safety protocols for areas like chemical handling and livestock.
Establish communication procedures for contractors on your farm, such as reporting lines.



Completion and feedback


Conduct a thorough inspection of completed work to ensure that all contractual obligations and required standards have been met.
Conduct a review to ensure that all relevant regulations and policies were followed by contractors.
Facilitate a two-way feedback process, enabling your business and contractors to grow and improve.
Finalise all documents including invoices, contracts and compliance reports.
