Issues covered (example)

Issue	Notes
Hazardous chemical storage	 Some chemical containers are stored near feed supplies, posing contamination risks. Labels on a few chemical containers are faded and hard to read.
Inadequate PPE usage	 Several workers observed not wearing gloves while handling chemicals. PPE inventory running low, particularly for eye protection and respirators.
Electrical wiring in need of repair	 Exposed wiring near the equipment shed identified as a potential fire hazard. Lights flickering in the machinery workshop, suggesting faulty connections.
Slippery floor in the barn	 Recent rainfall has caused pooling near the entrance, increasing slip risk. Straw and mud tracked in by animals worsening the slipperiness in key work areas.

Corrective action record: Chemical storage (example)



Issue	 Some chemical containers are stored near feed supplies, posing contamination risks. Labels on a few chemical containers are faded and hard to read.
Corrective action(s)	 Relocate chemical containers to a dedicated storage area Replace faded labels on all chemical containers


